No. PRA/Orders.06/2017(1), dated 5<sup>th</sup> July, 2017 In exercise of the powers conferred under clause (17) of section 2 of the Punjab Sales Tax on Services Act, 2012 (XLII of 2012), the Punjab Revenue Authority is pleased to specify the 10<sup>th</sup> day of the month following the tax period to which it relates, for furnishing of Annexure-C to the monthly sales tax returns to be filed under Chapter VI of the Punjab Sales Tax on Services Act, 2012.

- 2. There shall be no change in the due date for the payment of tax due and filing of monthly returns and other remaining annexures.
- 3. This notification shall be effective immediately in respect of sales tax returns to be filed for the tax periods July 2017 and onwards.


